With the installed plugin for Drupal, your customers will be able to pay with you through the payment page of «Sberbank». For the payment plugin to work, the Drupal Commerce module must be preinstalled in Drupal.

In the Drupal interface, add-ons are called «modules». The payment plugin falls into the same category, however the term «plugin» is used in this description.




Installing the plugin for Drupal 7.x Drupal Commerce 1.13

To install the payment plugin for Drupal, follow these steps.

- Unpack the archive and place the plugin folder in the following path: <site folder>\modules\.
- 2. Sign in to your online store website.
- 3. In the top bar of the site, select **Site settings > Advanced settings > Modules** (see image below).





5. Click to move the radio button from **OFF** to position **ON** - See image below.


