## WordPress

With the installed payment plugin for WordPress, your customers will be able to pay with you through the payment page of «Sberbank».

For the payment plugin to work, the WooCommerce plugin must be preinstalled on WordPress. The payment plugin was tested for compatibility with the following versions of WordPress and WooCommerce (see the table below).

Component	Version
WordPress	<b>4.x</b> and higher
WooCommerce	<b>3.x</b>

Recommended version of WordPress for working with the Sberbank payment plugin: not lower than 4.8.3.

Starting from this version, the plugin allows you to transfer a shopping cart, which provides the possibility of detailed fiscalization in accordance with [54-FZ](#).

You can download the required version of WooCommerce on [github.com](#) (link leads to WooCommerce version history).


In this description, the following components and versions are used as an example:

- content management system WordPress version 4.7.3;
- plugin WooCommerce version 2.6.14.


The WooCommerce plugin is not compatible with all WordPress themes. Here, the [Storefront](#) theme is used as example. This theme is designed by WooCommerce developers.

## Installing the plugin


1. Upload the plugin folder to your website server in the following folder:  
<site address>/wp-content/plugins/woocommerce-rbspayment/.
2. In the web interface of your site, log in to the console.
3. In the left pane, select **Plugins**> **Installed Plugins** (see image below).



The page will look as follows.




4. Click on the **Activate** link under the plugin named **Payment via RBS payment gateway**.
5. A **Plugin activated** message appears in the system message area above (see image below).



## Configuration

To set up a payment plugin for WordPress, follow these steps.

1. In the web interface of your site, log in to the console.
2. In the left pane, select **Plugins> Installed Plugins** (see image below).

4. Configure the settings using the table below.

Configuration	Description
<b>Enabled/Disabled</b>	The setting determines whether the plugin is enabled. <ul style="list-style-type: none"> <li>the checkbox is checked – the plugin is enabled;</li> <li>the checkbox is not checked – the plugin is disabled.</li> </ul>
<b>Title</b>	The title that the user sees during the checkout process.
<b>Login-API</b>	Login of a service account in a payment gateway with a suffix <b>-api</b> . If the plugin is running in test mode, you should specify the login for the test user account. If the plugin is running in production mode, you should specify the password for the production user account.
<b>Password</b>	The password for the service account in the payment gateway. If the plugin is running in test mode, you should specify the password for the test user account. If the plugin is running in standard (production) mode, you should specify the password for the production user account.
<b>Payments type</b>	Pick the payments type from the list. There are two options available: <ul style="list-style-type: none"> <li><b>One-phase payments;</b></li> <li><b>Two-phase payments.</b></li> </ul>
<b>Test mode</b>	Allows you to set the plug-in operation mode: test or live (working). <ul style="list-style-type: none"> <li>If the plugin is running in test mode, in the respective fields (<b>Login</b> and <b>Password</b>) you should specify the data of the test service account.</li> <li>If the plugin works in the live mode, in the respective fields (<b>Login</b> and <b>Password</b>) you should specify the data of the live service account.</li> </ul>
